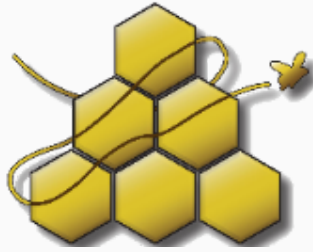

A popular mosquito repellent device emits an insecticide in vapor form to keep mosquitoes away, and a new study finds the vapor does not prevent honey bees from foraging in the same area. But whether it carries any long-term impacts on honey bees, or how it affects other bees and non-target insects, requires further study. Here, marked honey bees visit a feeder during the course of the study. Feeders were placed both within and outside the mosquito-repellent vapor plume, and between them the researchers found no significant differences in the bees' foraging frequency, waggle dance propensity, waggle dance frequency, and feeder persistence.
